
The appointment is purely temporary and may be terminated at any time without notice and without assigning any reason thereof.

The appointee should join in his appointed place of posting within 15 (fifteen) days from the date of this notification.


No T.A./ DA is admissible to the appointee either on joining in the posts or on termination of appointment.
